The Sealed Bids and the e- submitted bids shall be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM on 26 Magh 2077 at the office of Limchungbung Rural Municipality, Baraha, Udayapur. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum RS. Mention in table below which shall be valid for 30 days beyond the bid validity period
